Mission Statement

Tobermore Primary School believes in promoting spiritual, personal, social and academic goals desirable for our pupils. (a) Education Authority Representatives

(c) Parents' Representatives

Each Governing Body of a Primary School is entitled to have two parent representatives. They are elected by the parents of pupils attending the school and serve for the four-year term of each Board. The only qualification to be a parents' representative is that on the date of the election the proposed parent has a child attending the school:

The Principal of the school is secretary and a non-voting member.

Admissions Criteria for Year 1 Intake

Admissions criteria to be used in the event of the school being oversubscribed. The criteria are listed in order of priority.

- 1. Children who are resident in Northern Ireland at the time of their proposed admission.
- 2. Children who have reached compulsory school age.
- 3. Sibling relationships those children who have, or have had, brothers/sisters, half-brothers/sisters or foster brothers/sisters enrolled at Tobermore Primary School.
- 4. Geographical location preference will be given to children residing in and around Tobermore within 7-mile radius from proven residence to school.
- 5. Children who attend or whose brothers or sisters, half-brothers/sisters or foster brothers/sisters have attended ToberTinys Community Playgroup, Tobermore.
- 6. Children will be selected according to age eldest children will have priority.

Please note: It is parents' responsibility to ensure that any information which may be relevant to the above criteria is included on the Enrolment Process.

Duty to Verify

The Board of Governors reserves the right to require such supplementary evidence as it may determine to support or verify information on any application form.

If the requested evidence is not provided to the Board of Governors by the deadline given, this will result in the withdrawal of an offer of a place. Similarly, if information is supplied which appears to be false or misleading in any material way, the offer of a place will be withdrawn.

School Development Plan

In September 2020 staff created Action Plans on Numeracy, Literacy, Using ICT and Leadership & Management. Targets were set and were to be achieved by setting dates throughout the school year to monitor work, provide opportunities for professional development, sharing good practice and to improve teaching, learning and planning in Tobermore Primary School. These Action Plans were developed using the previous 2019 – 2020 examples, that were not completed due to the COVID 19 Pandemic

Staff/Curriculum Development

During this school year, the review and development of curriculum subjects has continued to fulfil the statutory requirements in relation to the breath and balance of the Northern Curriculum. Staff have continued to attend relevant training either provided by EA or in school where possible.

The use of our Shared Education programme also allowed for staff members to increase their professional development and share good practice within Tobermore Primary School and with St Columba's Primary School. This year we have continued to develop Health and Wellbeing with St Columba's Primary School as part of the Shared Education Action Plan that was created in 2019 – 2020.

Staff also carried out work in Literacy, Numeracy and UICT to develop progressive and continuous planning throughout each year group and Key Stage. Staff have developed 2 weekly planning notes, which will be evaluated and amended accordingly to ensure that adaptations will be made to teaching and learning, whilst ensuring that children have met their potential.

Standardised testing in year 3 to Year 7 took place in Term 3 this year due to COVID 19. The children from Year 3 to Year 3 were going to complete Progress Test English and Progress Test Maths on paper and complete digital Cognitive Ability Tests from GL Assessment.

Primary 1 Open Night and Induction Afternoon

There was no Open Night provided this year due to COVID 19 restrictions. Instead there was an option to visit the school via appointment on Wednesday 9th December 2020. Children and parents were then provided with an opportunity to tour the school, visit classrooms and meet staff.

There was an Induction Afternoon planned for parents on Friday 18th June 2020. Induction Packs were created for the new Year 1 children and Mrs Speers and Mr Cheevers presented information to parents.

Assessment and Achievement

The school is very proud of the achievements of its pupils. All pupils and teachers (P1-P7) are to be congratulated for their high level of commitment and hard work.

Staff provide a variety of collaborative and active tasks for pupils to take part in both inside and outside of the classroom.

End of Key Stage Results (2020 - 21)

In previous years at the end of each Key Stage pupils have been awarded a 'level' in line with statutory assessment arrangements. These levels are reported to CCEA, who then compare them with all the Primary Schools in Northern Ireland.

Since the introduction of these new levels of progression, there have been several well publicised criticisms of the new system. The guidance from CCEA that schools were asked to follow during the process has been interpreted differently by individual schools.

Most schools did not submit levels to DE due to industrial action therefore Northern Ireland accurate figures are not available for Northern Ireland. Following industrial action, the Board of Governors have decided not to award levels at the end of June 2021.

Standardised Tests

Tobermore Primary School carries out Standardised tests for Year 3- Year 7 in May each year as part of our screening process for low and underachievement, tracking of pupils and individual pupil target setting. The main assessments carried out are:

- GL Progress Test English (PTE) Paper
- GL Progress Test Maths (PTM) Paper
- CAT (Cognitive Ability Test) Digital

Transfer to Post-Primary Education

Tobermore Primary School enjoys an excellent working relationship with post- primary schools throughout the Magherafelt area. In June 2021 pupils of transfer age moved on to the following schools:

Child Protection and Safeguarding

The area of Child Protection is one that Tobermore Primary School takes very seriously. Concerns are investigated thoroughly, appropriate action taken whenever necessary. As a matter of course Governors are briefed on relevant issues during each meeting.

Parents, volunteers and new staff are working within the school continue to complete Access NI forms thus helping to ensure that all adults who have contact with pupils have had the necessary police checks completed.

Strategies have also been put in place to ensure that all pupils are aware of who can help them if they have any concerns. Many issues of Wellbeing have raised throughout the school year during class assembly, Circle Time sessions in individual classes and through curricular areas such as PDMU.

The pupils have also been provided with a Worry Box, allowing them to address issues which they may not feel comfortable talking to teachers about. This worry box is checked twice weekly and children are supported and any issues addressed on a whole school, class or peer group platform.

Security

The school is surrounded by fencing on all sides and the entire building has been fitted with an electronic alarm system. Pupils are always supervised by adults at playtime and exit gates from the playground are monitored. There has also been an increase in supervision of staff during playtime with 4 adults on duty at break time and 3 adults during lunch time. This is due to the segregation of playgrounds due to social distancing due to COVID 19.

External doors are secured during the school day to prevent access from the outside. All visitors must report to reception upon arrival. All visitors must sign into the Visitors' Book and a sign the 'Track and Trace' document as per COVID 19 protocols

A request has been made to EA Minor Works to enhance the security of the school with the addition of upgraded fencing around the perimeter of the school, CCTV and new external lighting. In addition to this, the school have requested an upgrade to the fire system in school and fire doors.

Pastoral Care

The pastoral care extended throughout Tobermore Primary School is excellent and fulfils the school's aim of creating an environment in which pupils are happy, secure, confident and valued.

Relationships between pupils and staff, and among pupils themselves, are extremely strong, and a caring and friendly atmosphere is clear throughout the school. The pupils are well mannered, and adults are excellent positive role-models.

The Safeguarding Team completed the ETI Proforma to provide guidance for the review and evaluation of Safeguarding and Child Protection procedures, polices and processes within Tobermore Primary School.

Tobermore Primary School Safeguarding Assembly

Safeguarding team/Boards

- Who they are? reference to board in front porch.
- Their job in school
- Role of Designated CP teacher/Deputy Designated CP teacher. Make children aware of posters around school- *If I am worried or sad, I can speak to....* Can anyone tell me where these may be in school?
- Refer to child friendly safeguarding board at the front of school refer to information on this board.
- Mention that every parent has received a safeguarding policy which shows all the ways we as a school keep the children safe.

Disclosure

- Discuss that children can disclose Safeguarding issues to all members of staff i.e. dinner supervisor, lollipop man etc.
- Refer to the fact that if an issue occurs outside school that issues can be disclosed to other adults such as family members, coaches, club leaders. Children should think of their 'Safe Person' later in class the children can draw this person.
- Discuss that if a friend has disclosed an issue to them, they should also disclose this to an adult.
- Children are reminded that if they do not want to speak out with peers in earshot that they will also be given a quieter/private place if they wish to disclose an issue.

Safety in school

- Buzzer system- on all doors
- No child ever allowed to buzz open a door
- All children aware of the evacuation procedures within school
- Fire alarm/fire safety point
- General good behaviour- physical movement around school- Children are reminded they are not allowed to enter a classroom until their teacher enters the classroom.
- All staff provided with Staff Lanyards and fob for all external doors. These fobs are numbered and each member of staff has been allocated their own fob.
- Any visitor to the school must sign in the Visitors' Book and wear a numbered lanyard, which they must record on the Visitors' Book. They must then sign out when leaving the school premises and return their lanyard.

Mrs Smyth (Designated Teacher for Child Protection) and Mrs Speers (Deputy Designated Teacher for Child Protection) completed an assembly on Safeguarding during their time at school and at home. At the end of the assembly all children will sign their name to show that they were in attendance for the assembly.

Special Educational Needs Provision

Tobermore Primary School prides itself on the provision of high-quality education for all the children attending the school. Some children at various stages of their development require a little additional help when they experience difficulties with a particular aspect of their work. To help these children several strategies have been employed during the year.

Classroom intervention - The needs of most children are met within the classroom, and where it is felt necessary Education Plans are drawn up, in consultation with pupils and parents, to target specific areas of weakness by Mrs J. Smyth (SENCO) and teaching staff.

One to one withdrawal support - External peripatetic teachers also provide support to pupils as part of the Education Authority - North-Eastern Region's Literacy Teaching Support Service outreach. RISE are also on hand to offer support on a one-to-one basis with pupils.

Booster groups – (small group teaching) Classroom assistants take pupils before school to support their learning and reinforce basic concepts. Class teachers and the SENCO identify pupils for booster groups using available data in both Literacy and Numeracy. Progress is monitored and most children make very good progress.

Tobermore Primary School also hired Miss E. Mullan to develop our Engage Programme. She worked with groups of pupils from Year 3 to Year 6, supporting them with Numeracy and Literacy.

The school liaises with several external agencies to support pupils identifying with SEN; these include:

Financial Report

Under the terms of Local Management of Schools (LMS), the Board of Governors are responsible for managing the entire delegated school budget.

The amount of money allocated to the Governors to run the school (common formula funding) depends largely on the number of pupils on rolls, with other factors such as the internal area of the school premises and the number of Newcomer pupils and pupils with Special Educational Needs also being considered.

Many of the school's financial commitments are predetermined by outside factors, e.g. basic staff costs, maintenance costs, etc, leaving the Governors a limited amount of the school's overall budget to allocate according to the school's priorities.

Tobermore Primary School's finances were support with the allocation of Special Needs, Wellbeing and COVID 19 money, which provided resources which did not directly affect the school's budget.

The use of our Shared Education Programme also provided much needed training, resources and facilitators to support teaching and learning.

A summary of the school's finances for 2020/21 is listed in **Appendix 1 and Appendix 2.**

Extra-Curricular Activities

Extra-curricular activities are a hugely valuable dimension to the children's school experience. In the past all children have received physical education, music and art within the curriculum and a wide range of after school activities provides further opportunities to develop skills and interests.

Residential Trip

This year, Year 5, Year 6 and Year 7 pupils did not take part in a Residential Trip due to COVID 19 restrictions. The year 7 pupils were taken to The Jungle for their end of year trip.

COVID 19 Pandemic

As with every school in Northern Ireland this year, Tobermore Primary School had to make adaptions in many ways to ensure the safety of our pupils, staff, parents and wider school community.

The following adaptions were made

- Hand sanitiser placed in every classroom;
- Hand sanitiser place at the front door of the school;
- Signage placed inside and outside school promoting social distancing, providing information to parents and creating an awareness of procedures in school;
- School website, school newsletter and Facebook pages provided updates from EA, PHA and school on COVID 19:
- Pupils' temperature was taken coming into school;
- Area for pupils displaying COVID 19 symptoms was created to isolate before being collected by parent/guardian
- Children continued washing and sanitising hands at various times of the day;
- Pupils in school remained in bubbles;
- Signage placed on floor to keep a one-way system;
- Enhanced cleaning in classrooms, toilets and other rooms in school at various times of the day;
- Fogging machine bought to enhance cleaning in school;
- Parent meetings took place over the telephone;
- All visitors into school had to arrange an appointment, sign contact tracing book, sanitise hands and wear a mask;
- Restrictions were placed in other rooms, to limit number of children;
- Cleaning products were provided to each classroom;
- Staggered break times and lunch times were created; and
- Homework was completed using Microsoft Teams (Year 5 to Year 7) and SeeSaw (Year 1 to Year 4).

Both teaching and non-teaching staff worked tirelessly to maintain a safe environment for everyone in the school community.

The school went into Lockdown from January 2021 to March 2021 and children took part in Home Learning using the online platforms. School had children from Key Workers in school during this time and work was completed based on packs that were sent home every 2 weeks.

Children from Year 1 to Year 3 returned to school on March the 8^{th} for full time teaching and the remainder of children returned to school on March 22^{nd} . Key Worker children from Year 4 to Year 7 continued until Monday 22^{nd} March.

Buildings and Maintenance

The school building is generally sound. The Board of Governors, along with the school Health and Safety team, survey the buildings regularly and identify any maintenance work required.

In January 2020, a request was made on behalf of the Board of Governors and the Principal, that the security of the school would be enhance with the addition of perimeter fencing, CCTV system and new security lighting. This work was approved, along with the addition of a new and updated fire system and fire doors in school. This work would hopefully begin in the 2021-22 academic year.

PAT testing was carried out as per EA guidelines.

Closing Remarks

Despite the challenging times that the 2020 - 2021 school year has provided to all schools this year, Tobermore Primary School continues to grow flourish and deliver the highest standard of education despite the COVID 19 pandemic.
